Ozfish Unlimited achieved a number of milestones this year and we are now well on our way to becoming the national organisation that can make a difference to our nations fisheries by gathering the support of recreational fishers and businesses. Some of the outcomes of the year include;

- Delivered Fishers for Fish Habitat Forums in Port Noarlunga (SA) and Albany (WA).
- Grew our membership from 53 to 170.
- Created our first Ozfish Chapters in the Richmond River (NSW) and in the Macquarie River (NSW) with Inland Waterways.
- Formed Partnerships with Recfishwest, Recfish SA, SEQ Catchments (now Healthy Waterways and Catchments and the Reef and Rainforest Research Centre.

### Notes to the Financial Statements OZ FISH UNLIMITED LIMITED For the year ended 31 October 2016

#### 1. Statement of Significant Policies:

The Directors have prepared the financial statements on the basis that the Company is a not-for profit, nonreporting entity because there are no users dependent on general purpose financial reports. This financial report is therefore a special purpose financial report that has been prepared in order to meet the needs of members.

The financial report has been prepared in accordance with the significant accounting policies disclosed below which the members of the Board have determined are appropriate to meet the needs of members. Such accounting policies are consistent with the previous period unless stated otherwise.

The financial statements have been prepared on an accruals basis and are based on historical costs unless otherwise stated in the notes. The accounting policies that have been adopted in the preparation of this report are as follows:

#### 1.(a) Revenue

Revenue comprises grant income, fundraising activities and membership fees.

Revenue is measured by reference to the fair value of consideration received or receivable by the Company for goods supplied and services provided, excluding GST.

Revenue is recognised when the amount of revenue can be measured reliably, collection is probable, the costs incurred or to be incurred can be measured reliably and when the criteria for each of teh Company's different activities have been met.

#### Grant Income

A number of the Company's programs are supported by grants received. If conditions are attached to a grant which must be satisfied before the Company is eligible to receive the contribution, recognition of the grant as revenue is deferred until those conditions are satisfied.

Revenue from s non-reciprocal grant that is not subject to conditions is recognised when the Company obtains control of the funds, economic benefits are probable and the amount can be measured reliably. When a grant may be required to be repaid if certain conditions are not satisfied, a liability is recognised at year end to the extent that conditions remain unsatisfied.

#### Interest income

Interest income is recognised on an accrual basis using the effective interest method.

#### 1.(b) Provisions:

Provisions are recognised when the company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

#### 1.(c) Cash and Cash Equivalents:

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other short-term highly liquid investments and bank overdrafts.

#### 1.(d) Trade Receivables and Other Receivables:

Trade receivables and other receivables, are recognised at the nominal transaction value without taking into account the time value of money. If required a provision for doubtful debts has been created.

#### 1.(e) Trade Creditors and Other Payables:

Trade creditors and other payables, including bank borrowings and distributions payable, are recognised at the nominal transaction value without taking into account the time value of money.

#### 1.(f) Goods and Services Tax:

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the balance sheet are shown inclusive of GST.

#### 1.(g) Income Taxes

No provision for income tax has been raised as the Company is exempt from income tax under Div 50 of the *Income Tax Assessment Act 1997*.

#### **Report on the Financial Report**

I have audited the accompanying financial statements, being special purpose financial statements of OzFish Unlimited Limited, which comprises the balance sheet as at 31 October 2016, the profit and loss statement for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information, and the Board's declaration.

#### Responsibility of Those Charged with Governance

The Board is responsible for the preparation of financial statements that give a true and fair view and have determined that the basis of preparation described in Note 1 to the financial report is appropriate to meet the requirements of the *Australian Charities and Not-for-Profits Commission* and is appropriate to meet the needs of the members. The Board's responsibility also includes such internal control as the Board determines is necessary to enable the preparation of financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

#### Auditors' Responsibility

My responsibility is to express an opinion on the financial statements based on my audit. I have conducted my audit in accordance with Australian Auditing Standards. # Annual Report (Oct 1 2015 – Sept 30 2016) OzFish Unlimited – Richmond River Chapter

## Activities and Action achieved

- Ongoing engagement of area stakeholders (Councils, Land Services, NPWS, Fisheries) re efforts to restore river health
- Travel to Noosa Heads to discuss rehabilitation project on Noosa River (Thomas Foundation)
- Meeting with OEH Minister (State) re Tuckean swamp
- Submitted Habitat Action Grant funding application for deployment of large hardwood tree systems being made available by RMS. To be deployed into Emigrant Creek
- Planting of 980 trees (riparian) north and south of Ballina (4 days in total plus planning)
- Joint project with DPI Fisheries (Mike Dove Port Stephens) trialling different diseases resistant families of Sydney Rock Oysters into the lower Richmond.
- Ongoing monitoring of agricultural flood mitigation drains on the Richmond Floodplain
